- (4) Form A shall be signed by the appellant personally. If the appellant is a registered company/business or a society or an association or other body of person, Form A shall be signed by the Chairman, Director, Secretary or any person authorized by the company/business, society/association or any body of persons.
- (5) Form A shall be filed in four copies in the Tribunal's registry upon payment of fee of one hundred ringgit. All the copies shall be sealed and signed by the Secretary of the Tribunal. One copy shall be returned to the appellant.
- (6) The appellant may be represented by any person authorized by the appellant, except an advocate and solicitor.
- (7) The appellant shall attach to the notice of appeal any documents in support of the appeal.
- (8) Separate attachments may be enclosed if necessary.
- (9) A copy of the following documents shall be attached with this notice:
  - (a) Identification Card/Passport of the person filing the appeal;
  - (b) Identification Card/Passport of the appellant;
  - (c) Certificate of Company/Business Registration;
  - (d) Certificate of Association/Society Registration;
  - (e) Authorization from Company/Business/Association/Society; and
  - (f) Document containing the disputed decision of Director General of Customs.
