# 35TH LAKSANA REPORT

IMPLEMENTATION OF THE PRIHATIN RAKYAT
ECONOMIC STIMULUS PACKAGE (PRIHATIN),

KITA PRIHATIN ECONOMIC STIMULUS PACKAGE (KITA PRIHATIN)

#### INTRODUCTION

- 1. I trust everyone is safe and in good health, particularly for those in states that are experiencing floods during this monsoon season. I trust everyone is also in compliance with the stipulated SOPs to curb the spread of the COVID-19 pandemic.
- 2. The 35th LAKSANA Report is also the first report for the new year 2021. This report will begin with the implementation status of the PENJANA and KITA PRIHATIN initiatives, while the implementation status of the PRIHATIN initiatives can be found in Appendix 1.
- 3. Allow me to start by quoting some news report from an international media company<sup>1</sup>, which ranks Malaysia in 5<sup>th</sup> place as a key investment and business destination among the world's developing economies for 2021, surpassing countries such as China, Philippines, India and Indonesia.
- 4. This is based, among others, on the potential for rapid economic recovery, as well as the country's stable fiscal and financial position. Furthermore, based on the effective lockdown index, an international consultant predicts that Malaysia is among the 3 countries with the most room to control and alleviate the COVID-19 pandemic in 2021, and once this is done successfully, our economy is expected to rebound faster.

- 5. I would also like to quote a report by an international consulting firm<sup>2</sup> which concludes that Kuala Lumpur remains attractive to the international business community. This considers factors such as integrated infrastructure facilities, diversity and quality of human resource, as well as our country's readiness to adopt digital technology.
- 6. I would like to add that the period for various tax and investment incentives through PENJANA has been extended through Budget 2021. This includes special tax rates for selected manufacturing companies that relocate to Malaysia and make new investments (incentives extended for another year until 31 December 2022) and tax incentives to companies in selected services sector with a significant multiplier effect, with an income tax rate of 0 10% only, for a period of 10 years.
- 7. While the Government is planning the nation's economic journey post COVID-19, certainly any decision must balance between existing resource management, as well as positive or multiplier impact in the short and long term. This approach will continue to be practised by the Ministry of Finance in the formulation of each policy.

# **PENJANA (National Economic Recovery Plan)**

- 8. Under PENJANA, the initiatives are focused on three main objectives, namely:
  - a. Empowering the People;
  - b. Propelling Businesses; and
  - c. Stimulating the Economy.

## PENJANA OBJECTIVE 1: EMPOWERING THE PEOPLE

- 9. First, the PEKA B40 Health Care Scheme (PeKA B40) to meet health needs such as early detection for non-communicable diseases especially for the B40 group. Eligible persons are recipients of Bantuan Sara Hidup (BSH) and registered couples aged 40 and above. Between the period of 1 July and 25 December 2020, a total of 191,737 claims were received, valued at RM19.57 million (compared with 186,312 claims with a total of RM18.35 million as of the previous week).
- 10. Second, the Wage Subsidy Program (PSU) (first phase or PSU 1.0). As of September 30, 2020, the closing date of PSU 1.0, a total of 322,177 employers and 2.64 million employees had received PSU benefits under PRIHATIN and PENJANA. As of 25 December, approved wage subsidy applications reached a value of RM12.682 billion (compared with RM12.608 billion as of the previous week).

11. Third, Hiring Incentive Programme and Training Assistance. As of 25 December, a total of 128,778 employees had secured employment through this programme (compared with 122,126 employees as of the previous week). This number includes 102,623 people under the age of 40; 17,394 people for the age group of 40 and 60, as well as 7,417 apprentices and 1,344 people with disabilities (OKU). Among the key industries and sectors actively hiring include manufacturing as well as wholesale and retail trade.

12. Fourth, Reskilling and Upskilling Programme. As of 25 December, a total of 130,385 individuals had been approved to participate in the programmes provided (compared with 129,667 individuals as of the previous week). The list of courses that are requested can be seen through the Ministry of Finance link. In addition, applicants can also visit the websites of Government agencies as listed below, to obtain information on the courses offered. Those who are looking for a job, especially youths, are invited to participate in these courses.

13. **Fifth, public transport subsidy MY30.** As at 25 December, a total of RM127.74 million has been channelled for the subscription of 751,414 unlimited monthly public transport passes worth RM30, which is provided specifically for Malaysian citizens (compared with RM123.8 million for 728,225 monthly passes as of 11 December 2020). As announced under the Budget 2021, this initiative is extended to 2021 to further promote mobility and reduce the burden of public transport costs for the People.

## PENJANA OBJECTIVE 2: PROPELLING BUSINESSES

14. **First, PENJANA SME Financing**. The Government's allocation of RM2 billion under this programme gives priority to SMEs that have never received a loan from a bank before. The amount and value of loans approved are as follows.

- 15. Second, PENJANA Tourism Financing with a total allocation of RM1 billion specifically for SMEs and micro SMEs in this sector who are still affected by COVID-19. As of 25 December, there are 550 applications for this financing, and of this total 261 applications had been approved with a total financing of RM52.8 million (compared with 245 applications with a value of RM49.9 million as of 11 December 2020).
- 16. **Third, TEKUN Business Recovery Scheme (TBRS),** is also special for Micro SMEs. As of **25 December,** a total of **RM99.4 million** had been channelled under TBRS, benefitting **14,893 Micro SMEs.**

17. The fourth is PENJANA Credit Micro Financing under Bank Simpanan Nasional (BSN). As of 25 December, a total of RM282.8 million had been channelled to benefit 8,158 Micro SMEs including in retail and services.

18. **Fifth, Bumiputera Relief Financing (BRF)** which managed by Perbadanan Usahawan Nasional Bhd (PUNB). The RM200 million special fund assistance is meant for Bumiputera SMEs affected by COVID-19, with financing **between RM100,000 and RM1 million** for the SMEs. As of **25 December**, this fund had been channelled to **322 SMEs** involving a value of **RM82.8 million** (compared with 270 SMEs with a total of RM68.2 million as of 11 December 2020).



#### PENJANA OBJECTIVE 3: STIMULATING THE ECONOMY

- 19. First, support for the Agriculture and Food Industry for farmers, ranchers and fishermen. Of the total allocation of RM400 million, RM350 million is an allocation under the Agrobank Microcredit Financing Scheme. As of 25 December, a total of RM64.7 million had been channelled under this scheme to benefit 6,325 Micro Agricultural SMEs (compared with RM60.9 million for 6,094 Micro Agricultural SMEs as of 11 December 2020).
- 20. Second, 100% export duty exemption to the commodity sector which also includes the palm oil-based industry, to stimulate the growth of the country's commodity sector and export value. This initiative facilitates smallholders' sale of their produce to factories. As at 25 December, the value of export duty exemption successfully utilised by the country's commodities industry is RM426.9 million (compared to RM373 million as of 11 December 2020).
- 21. Third, sales tax exemption for passenger vehicles. These sales tax incentives include a 100% exemption for locally assembled cars (CKD Complete Knocked Down) and a 50% reduction for full import (CBU Completely Built Up) models. As of 25 December, the value of sales tax relief that had been utilized is RM197.57 million (compared with RM192.7 million as of the previous week). As announced last week, the Government has agreed to extend this tax incentive until 30 June 2021, as a measure to further boost the automotive sector and the country's economic activity.

### KITA PRIHATIN ECONOMIC STIMULUS PACKAGE

- 22. **First, for the Bantuan Prihatin Nasional 2.0 (BPN 2.0),** the process of reviewing new applications and appeals is still underway. The government will announce the date of payment of the second phase in the near future, as well as new applications and approved appeals, which are expected to be channeled starting this month as well. The fulfillment of the first phase of BPN 2.0 through BSN for those whose accounts failed to be credited is still ongoing.
- 23. **Second, for the PRIHATIN Special Grant (GKP) 2.0**. The process of reviewing new applications and appeals is in the process of cross-checking between the LHDN and the Local Authority, and the results will be announced in the near future.
- 24. Third, PSU 2.0 under the KITA PRIHATIN package. As at 25 December, a total of RM418.67 million had been channelled to 39,203 employers to continue operating and maintain employment for 307,420 employees (compared with RM239.73 million for 51,022 employers and 420,193 employees as of the previous week).

- 27. The Government will continue to work with local authorities and non-governmental organizations to assist flood victims, and ensure that infrastructure in the affected areas are restored. InsyaAllah, the Government is ready to increase the allocation where necessary.

Finally, allow me to remind all of us to continue to follow the SOP in conducting economic activities and daily life, especially with school holidays, public holidays and cross-state activities. Although the COVID-19 vaccine will be supplied starting this February, take note that the staff of the Ministry of Health and the front-liners are still working hard to curb this epidemic for our safety. We must also see ourselves as frontliners, helping to curb COVID-19 in terms of SOP compliance and by reminding each other.

As of 25 December 2020, a total of RM455.23 million has been channelled based on 1,361,424 claims (compared with RM44.94 million involving 1,334,569 claims as of the previous week) comprising doctors, nurses and other medical personnel directly involved in the management and containment of the COVID-19 pandemic.</li> <li>b. This special allowance is also extended to members of the military, police, customs, immigration, fire brigade, members of the Civil Defense Force as well as RELA members who are directly involved in implementing the Movement Control Order (MCO).</li> </ul>
3.	Electricity Bill Discount	<ul> <li>a. As of 25 December 2020, a total of RM2.10 billion in the form of electricity bill discounts (compared with RM2.08 billion as of the previous week) has been channelled to 8.6 million domestic consumers of electricity supplied by Tenaga Nasional Bhd.</li> <li>b. This electricity bill discount is an extension of the Bantuan PRIHATIN Elektrik introduced during the PRIHATIN package. As of **25 December 2020**, the total number of applications approved by local banks and approved by SMEs is **RM11.29 billion** which will benefit **24,012 SMEs**. This amount includes Special Relief Facility (SRF), Automation & Digitalisation Facility (ADF), All-Economic Sector Facility (AES) and Agrofood Facility (AF) funds.
